गदरपुर (उद संवाददाता)।क्रिकेट और खिलाडी पंजीकरण फॉर्म क्रिकेट एसोसिएशन आफ उधम सिंह नगर के कार्यालय से प्राप्त कर सकते हैं। अंडर-19 के क्रिकेट खिलाड़ियों की कट ऑफ डेट 1 सितंबर 2003 है। खिलाड़ियों को पंजीकरण के लिए आवश्यक प्रमाण पत्रों में वर्तमान से पिछले 2 वर्षों के शैक्षिक प्रमाण पत्र, हाईस्कूल और इंटरमीडिएट का प्रमाण पत्र, कंप्युटराइज जन्म प्रमाण पत्र, वोटर आईडी, पासपोर्ट, स्कूल का स्थानांतरण प्रमाण पत्र लगाना अनिवार्य है। अंडर-19 जिला क्रिकेट लीग प्रतियोगिता के माध्यम से ही जिला उध म सिंह नगर की अंडर-19 क्रिकेट टीम का चयन किया जाएगा जो सीएयू
